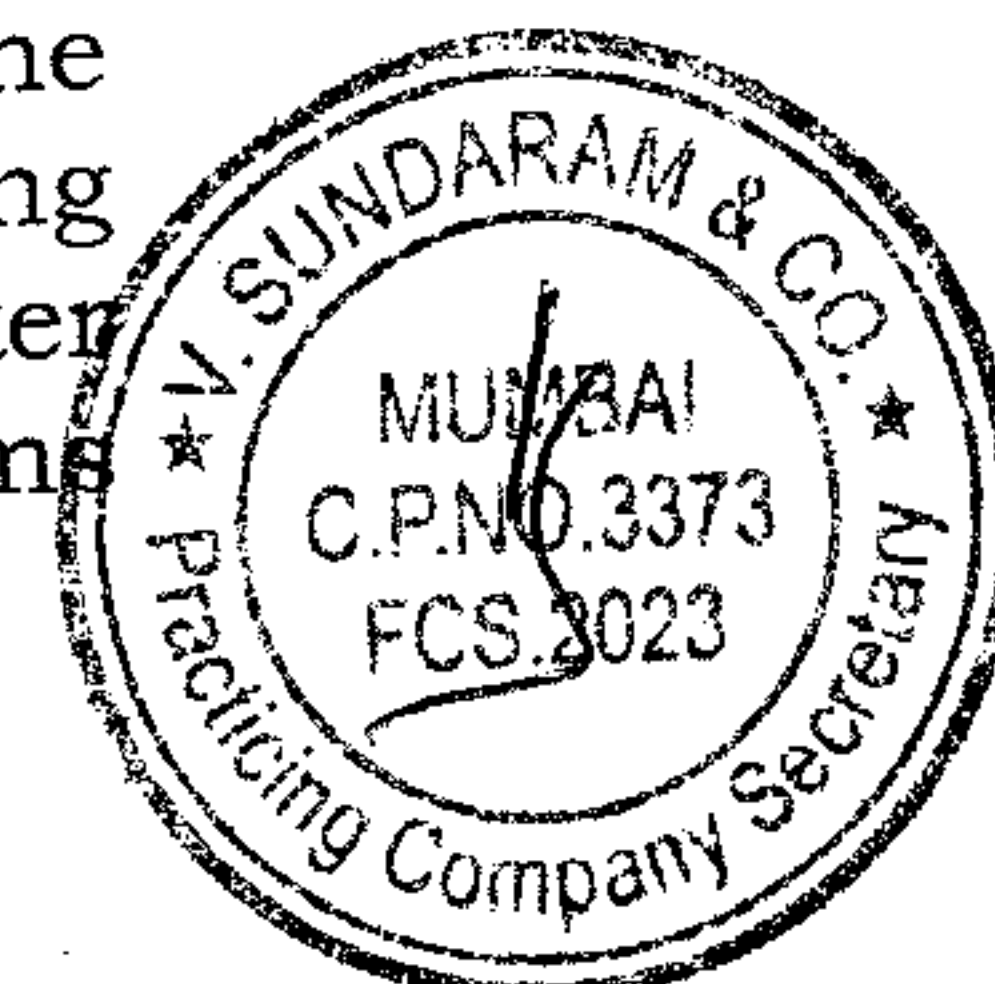

Sub: Result of Postal Ballot conducted by Dolphin Offshore Enterprises (India) Ltd, (the Company), under Section 110 of the Companies Act, 2013 ("the Act") read with the Rule 22 of the Companies (Management and Administration) Rules, 2014.

1. The Board of Directors of the Company at its meeting held on 20<sup>th</sup> October, 2014 had appointed me as a Scrutinizer for conducting the Postal Ballot voting process under provisions of Section 110 of the Companies Act, 2013 ("the Act") read with the Rule 22 of the Companies (Management and Administration) Rules, 2014, in respect of Postal Ballot Notice dated 20<sup>th</sup> October, 2014 for the below mentioned Resolutions:

I	Limits of Borrowings u/s 180(1)(c) of the Companies Act, 2013.
II	Providing security u/s 180 (1)(a) of the Companies Act, 2013 in connection with the Borrowings of the Company
III	Consent for making any investment/Giving any loan or Guarantee/ Providing security.
IV	Alteration of Articles of Association of the Company.

2. The Company had appointed NSDL as the service provider, for extending the facility of electronic voting to the shareholders of the Company from 09.00 A.M. on Friday, 5<sup>th</sup> December 2014 to 6.00 P.M. on Saturday, 3<sup>rd</sup> January 2015. After the date and time fixed for closing of the e-Voting, the site was blocked by us.
3. The Management of the Company is responsible to ensure the compliance with the requirements of the Companies Act, 2013 and Rules relating to e-voting and physical postal ballot on the resolutions contained in the notice to the Postal Ballot of the members of the Company. My responsibility as a scrutinizer for the voting process is restricted to make a Scrutinizer's Report of the votes cast "In favour" or "against" the resolutions stated above.
4. Based on the report generated from the e-voting system provided by the NSDL, the Authorized Agency engaged by the Company to provide e-voting facilities and the Postal Ballot papers received by the company and after completing my detailed verification of both e-voting and physical forms received, I submit my report as under:



- On 4<sup>th</sup> December, 2014 the Company had completed the dispatch of postal ballot forms along with postage prepaid business reply envelope to its Members whose name(s) appeared on the Register of Members as on 21st November, 2014.
- Particulars of all the postal ballot forms received from the Members have been entered in a register separately maintained for the purpose.
- The postal ballot forms were kept under safe custody before commencing the scrutiny of such postal ballot forms.
- The details of postal ballot forms and those under e-voting were scrutinized by me and the shareholding was matched / confirmed with the Register of Members of the Company.
- All postal ballot forms received up to the close of working hours on 3<sup>rd</sup> January, 2015 the last date fixed by the Company for receipt of the forms were considered for my scrutiny. The e-voting done through NSDL and details given by them were also verified and considered.

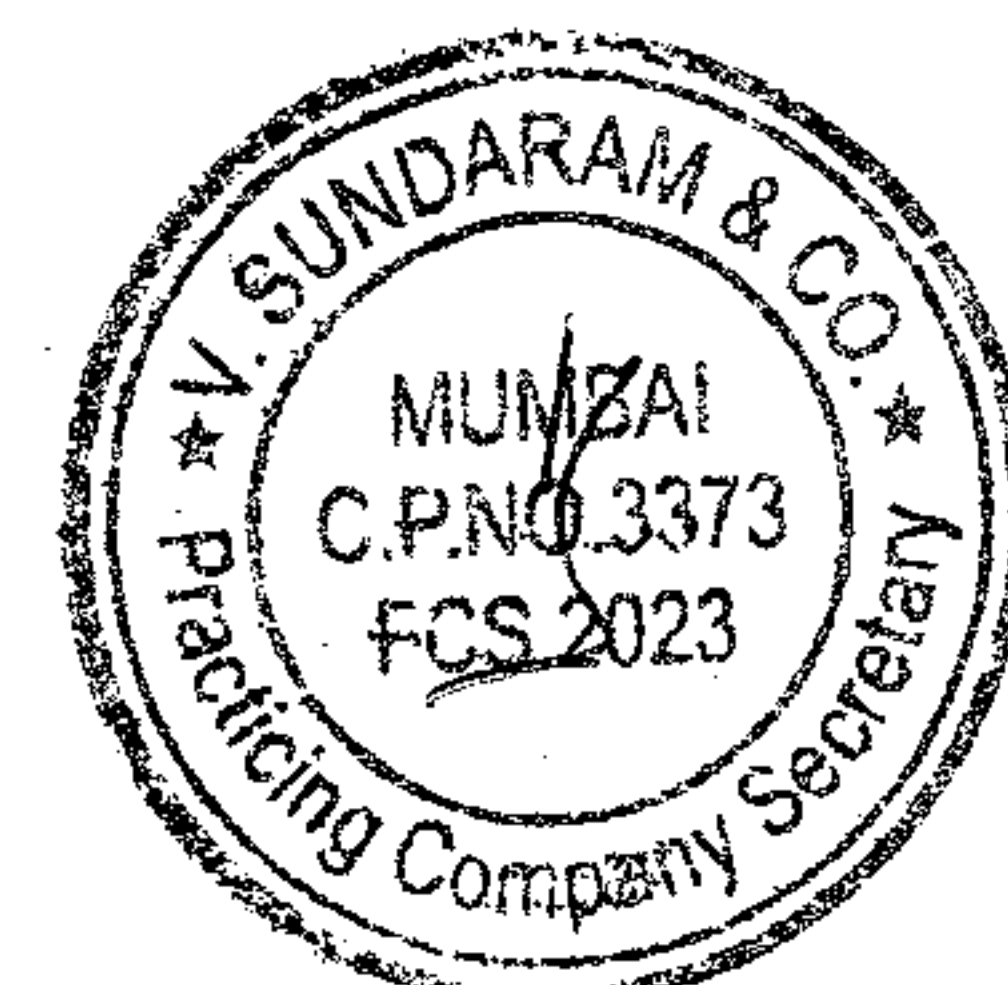

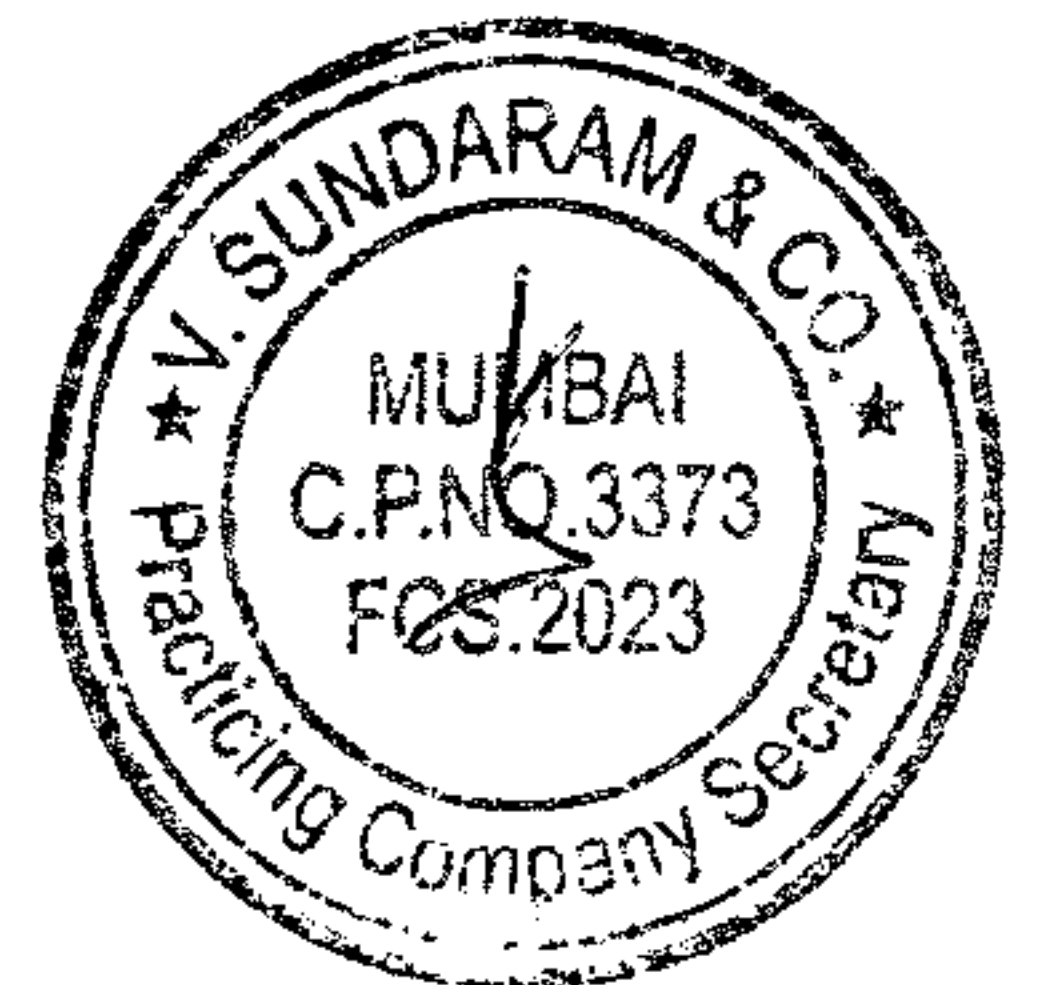
