Therefore the public shareholdings of 7578515 equity shares were reduced to 95298 equity shares.</p> <p>Since the company is in process of obtaining the necessary approval for capital reduction and preferential allotment henceforth there is a difference between data provided by the depositories and company records. The filed SHP is on the basis of Company's available records.</p>
